## The Small Print or (Terms & Conditions 2018/19)

1. Definitions:
  - a. The **'Introducer'** is the current annual berth holder renewing their annual berthing contract for the 2018/19 season.
  - b. The **'Friend'** is a new customer to the marina that has not been an annual or seasonal berth holder at Salterns since 1<sup>st</sup> August 2017.
  - c. **Annual Berthing Contract** including membership of 'The Club' at Salterns relates to the season commencing from 1<sup>st</sup> April 2018 to 31<sup>st</sup> March 2019.
  - d. **Credit Vouchers** may be used at the following locations which are all part of the Salterns Group.
    - i. For all products and services at Golden Arrow Marine
    - ii. Off boatyard services such as lifting / valeting
2. Credit Vouchers are not transferable and cannot be redeemed for cash or any other benefits not listed above and not in conjunction with any other promotion.
3. This scheme is designed to incentivise existing Salterns annual berth holders to introduce new customers to the business.
4. Credit Vouchers will remain valid until 31<sup>st</sup> March 2019 after which any unused portion will be lost.
5. This offer applies to vessels that are privately owned and are solely used for pleasure purposes.
6. In the event of an early contract termination or if there is a serious breach of the Marina Regulations, Salterns Marina Ltd reserves the right to withdraw any unused credit issued to either party.
